Eligibility

The dwelling unit:

- a. Must be occupied by the person claiming the discount;
- b. Claimant must be head of the household;
- c. Utility account must be kept current; and
- d. No person may claim a discount for more than one dwelling unit during the same period.

The claimant must qualify in one of the following two categories throughout the period for which the discount would be applied towards all City of Marysville billed utilities except Yard Waste service, which is optional.

1. Low-income senior citizen.
 - a. At least 62 years of age; and
 - b. Income limit based on household size listed below (defined by the HUD very low income limit)
2. Low-income disabled: Household income is at or below the HUD Guidelines* and claimant:
 - a. Qualifies for special parking as defined by RCW 46.16.381; or
 - b. Is blind as defined by RCW 74.18.020; or
 - c. Is disabled, handicapped or incapacitated as defined by any other existing state or federal program.

Income

Defined by RCW 84.36.383 (5)

Adjusted gross income as defined in the federal internal revenue code, as amended prior to January 1, 1989, plus all of the following items to the extent they are not included in or have been deducted from adjusted gross income:

- a. For renewals only, reapply with a tax return by, June 1st.
- b. Capital gains;
- c. Amounts deducted for loss;
- d. Amounts deducted for depreciation;
- e. Pension and annuity receipts;
- f. Military pay and benefits other than attendant-care and medical-aid payments;
- g. Veterans benefits other than attendant-care and medical-aid payments;
- h. Federal social security act and railroad retirement benefits;
- i. Dividend receipts; and
- j. Interest received on state and municipal bonds
